

# Weekly Vacuum Package

## Our Crystal Clear Signature Valet Package includes:

Summerization, Winterization - One vacuum call each week between Memorial Day and Labor Day.

*The charge for services shall be in the amount totaling \$2,555*

### Convenient schedule of payment terms:

- \$500 is required to schedule a Summerization
- \$450 is due the day the pool is Summerized
- \$450 is due on the 15th of June
- \$450 is due on the 15th of July
- \$450 is due on the 15th of August
- \$255 is due the day the pool is Winterized

\*All seasonal chemicals are supplied at additional cost.

If draining or cleaning the pool is required, there is an additional charge of \$1500.00 & up.

\*Pools with solar cover additional charge.

\*See Additional Charges on Reverse side.

\*Pre & Post Season valet can be scheduled for an additional charge.

### Valet Package Includes:

- Summerize pool and clean cover.
- Put pool and filtration equipment in service for spring operation.
- One service call per month, if required.
- Vacuum pool weekly from Memorial Day to Labor Day.
- The following chemicals included in the weekly valet are: calcium chloride flake, soda ash and sodium bicarbonate
- Skim water surface to remove floating debris on each visit.
- Test pool water chemistry for proper chlorine, bromine, PH, alkalinity, calcium hardness, and treat as necessary.
- Backwash filtration system when necessary.
- Brush down walls and tile line as necessary.
- Clean filter room or mechanical pit as needed.
- Furnish service report after each visit.
- Winterize pool and apply cover.

**NOTE:**  
1st waste vacuum of season not included.

If account is not kept current, there will be an interruption in service without notice. • Payments due day of Service.

# Summerization Services —

- Plan 1 \$500** **OPENING WITH COVER – POOL WITH SPA:**  
Remove, clean and store pool cover on owner's / lessee's premises. Install pool equipment. Reassemble and activate filter system for summer operation.
- Plan 2 \$440** **OPENING WITH COVER – POOL ONLY**  
See above for description
- Plan 3 \$445** **OPENING WITHOUT COVER – POOL WITH SPA:**  
Reassemble and install pool equipment. Reassemble and activate filter system for summer operation.
- Plan 4 \$370** **OPENING WITHOUT COVER – POOL ONLY**  
See above for description

Pump out, clean out all debris, wash pool interior. Please note: When calcium or magnesium scale or stains exist, the degree of treatment necessary to effect removal is possible to be such that the white plaster or painted finish will be affected. Crystal Clear Signature Pools, LLC, Inc. takes no responsibility for any damage to the plaster or painted finish as a result of this treatment.

**NOTE:** Any water and/or leaf removal on cover will be an additional charge of \$100.00 and up.

**NOTE:** Water level must be at mid-tile mark before your scheduled date to avoid an additional charge for a 2nd visit.

## Contract Terms —

1. Annually, homeowner shall have a licensed electrician, experienced in swimming pools inspect and certify your equipment is properly grounded, bonded and protected by GFCI circuits according to article 680 of the electric code.
2. Crystal Clear Signature Pools, LLC (CCSP) agrees to carry in full force and effect Public Liability and Property Damage Insurance and Owners and Contractors Public Liability and Property Damage Insurance in addition to the Workman's Compensation insurance required by law.
3. Should an occasion arise during the period of this contract which in the opinion of the owner merits adjustment in the contract price and other action, it shall be the owner's responsibility to notify CCSP in writing within ten (10) days.
4. CCSP shall not be held responsible for any damage to the pool, its decks or other related parts due to hydrostatic pressure (water pressure) should it occur during the emptying of the pool for cleaning, painting or repairing or while the pool is left empty for filling.
5. This agreement becomes valid upon our receipt of the attached card properly signed by the owner (or lessee), accompanied with the required remittance and accepted by CCSP

6. Should payment on this account be in default and should it be necessary for CCSP to obtain legal representation and/or institute suit for collection then the Owner or Lessees agree to pay in addition the amount due and owing, interest thereon; and, any and all reasonable attorneys fees and costs of suit.
7. The Owner or Lessee shall be responsible for the maintaining a satisfactory level of all chemicals & chlorine, in the pool between vacuum visits, CCSP assumes no liability for an unsatisfactory chemical level.
8. CCSP shall not be held responsible for any damage to lawns, shrubbery, or landscaping due to discharging of water and its contents when emptying the pool, cleaning the filter system and cover.
9. CCSP cannot be held responsible for discoloration or cracking of plaster, decking, coping, stonework, etc...

### GUARANTEE

Should any defects arise in the filtration system, heater, pump unit or sanitizing system due to improper winterizing or defective materials used by CCSP such defects shall be repaired at no cost to the Owner. Guarantee shall not include pool's finish or shell, decks, tile or coping. Not responsible for underground piping, drains, wall fittings, skimmers, pre & post winterization.
